Bringing you along took a lot of time, money, and maintenance with no guarantee

their investment in you would amount to anything, much less pay off as it has for Mr. and Mrs. Spears and the Lohans.

Your government has plans for you like it or not, beginning with a formal education to insure you will eventually fit into one of the pigeon-holes they prepare for maturing members; it's a tedious and expensive process of many years that you will often curse. You must listen to many tales of what happened in the past, some true and interesting, and many others not so much. You will be taught many lessons designed to guide your behavior, prompt you to consume and contribute, and shield humanity from whatever iniquitous activity you may come to fancy. It is normal for you to believe your teachers, the news, and your government. You are not at fault believing all that you do but the fact is you have been bred on lies—many lies—over many years. Do not blame your parents; they only passed along the lies *they* were told and came to believe.

In what follows you will have a chance to examine what has been skillfully and secretly slipped into your mind. There is no need to become defensive; you're not at fault. Your educators have had more than a hundred years to perfect their craft and when you see how the truth compares with what you were told, *you will* recognize the difference. It's not your fault that you believe as you do; the channeling forces are hard-wired by centuries of having their own way; you never had a chance until now.

The work you are reading will not preach what is right because its purpose is to dwell on what is wrong. It *will* inform; you remain free to work your own path. It will expose lies convincingly told through the years for the benefit of a very wealthy upper class of politicians, priests, bankers and socialites positioned as “your betters” with their ubiquitous **status quo** that you must never, for any reason, upset. My research engendered great vitriol that may deny my credibility, for in my revelations much anger becomes evident in and between the lines that I might easily be perceived a raving quack on a personal vendetta without a good word to say about anything. Of need, it cannot be otherwise for I tell you about the bad news. Much of this book is about bad news with very little good to be shared—not even a happy ending. I do not see a happy ending. My generation cannot provide you with a happy ending because we—the passive ones—are the problem for allowing things to develop as they have. Meanwhile, a relatively few whose names you may recognize have worked feverishly to bring about ruinous conditions while we passives were thrilling to our sports teams, our celebrity scandals, our favorite musicians and reality shows, indulging ourselves to obesity, ignorant of—even honoring—those evil few who were relentlessly stealing our future, our country, and our lives.

“They” are the ones responsible for all the major problems we currently face: high taxes, high unemployment, costly energy and gasoline—actually, the high cost of everything. Electronic voting machines now determine election winners by which side has the best hackers. Minds and perceptions are shaped by video games. We are told that a rag-tag band of religious malcontents make us afraid to live our lives and as I write this, plans to disarm American citizens are being advanced. In December of 2001, the FBI revealed an operation called “Magic Lantern” that allows it to use the Internet to secretly plant a program in anyone’s computer so that every stroke made on the keyboard will be reported back. That means the government now can capture a record of everything you create on your computer including passwords, encrypted files and even deleted files. The Patriot Act of 2001 has authorized Homeland Security to override our Constitution usurping most of our rights including privacy. Further insults were added after that government foot was wedged in the door. Now, personal property may be searched and seized without a court order; citizens may be arrested without a warrant and imprisoned without trial ((112<sup>th</sup> Congress (2011-2012) S.1867 National Defense Authorization Act – NDAA 1021)). Public surveillance cameras are appearing everywhere; the government has implemented a national identification and bio-recognition system, and the FBI places wiretaps on telephones without a court order.

To the anger and frustration of “They”, Edward Snowden has blown the cover off The National Security Agency (NSA) for the capturing and storing of *all* your private communications sanctioned by their ubiquitous claim of “national security”. Bradley Manning was

convicted in a military Court for revealing secret documents describing criminal activity by our government services around the world. Lethal drones have become the silent weapon of choice when the military *thinks* it has a hostile target.

Whistleblowers are arrested and imprisoned for telling you what you need to know about how your government really operates when nobody is looking.

# All You Need to Know About...

## CHAPTER ONE – BANKS, the FEDERAL RESERVE, and ZIONISM

“Let me control a nation’s money and I care not who makes its laws.”

— Nathan Amschel Rothschild in 1838<sup>4</sup>

This chapter dealing with banks, the Federal Reserve, and Zionism is, without doubt, the most important to read early because it explains *how* so much of what is a fact in other subjects can be true and understood. It will be difficult to believe a single faction can purposefully be responsible for all our serious problems, but you have only to read, watch, and analyze.

A single faction—“Why would they?” you ask.

In his best-selling book, “The Creature from Jekyll Island,” author and documentary film producer, G. Edward Griffin, tells you the origin of that single faction. In its 1910 beginning, a group of bankers were called together by Senator Nelson W. Aldrich, Chairman of the National Monetary Commission, *to a secret meeting* at Jekyll Island, Georgia. Attending were Abram Piatt Andrew, Assistant Secretary of the Treasury; Frank A. Vanderlip, President of the National City Bank of New York, representing William Rockefeller and Kuhn, Loeb & Company; Henry P. Davison, Senior partner of the JP Morgan Company; Charles D. Norton, President of the First National Bank of New York; Benjamin Strong, Jr., Head of JP Morgan’s Trust Company; and Paul M. Warburg, partner in Kuhn, Loeb & Company representing the Rothschild banking dynasty in England and France. **Between them, these men controlled one-fourth of the world’s wealth.**

“Why would they?” was the question.

These greedy men met in secret in 1910 and formed a cartel<sup>5</sup> **because they wanted to control all** of the world’s wealth.

They achieved that goal some time ago and now, with all the money their families could frivolously spend in a dozen lifetimes, their sights have shifted to power—global power—already an impending probability in the United States as the great majority of your leaders through the last seventy years have subscribed to membership in the **Council on Foreign Relations<sup>6</sup> (CFR), The Bilderberg Group (BG), and/or the Trilateral Commission (TC)**, three entities working toward the Zionist<sup>7</sup> cartel’s “New World Order” (NWO). To succeed, the banking cartel must **erode America’s national sovereignty** by creating and/or exacerbating the problems we currently face, implementing what is called the Hegelian Dialectic (Problem, Reaction, Solution), to break you down, make you dependent; whereupon, you will welcome *their* solutions and allow the United States to be slowly “blended in” with the “Star Wars Bar” collection at the United Nations—many already under the cartel’s full control.

That is the why—now look at how.

Everyone at one time or another will need to borrow money—business to expand, politicians to campaign—governments need to borrow for everything they want and to *be able to borrow* all will need a good relationship with a bank. That means they must *be able* to give the bank what it requires, and that will be different things to different borrowers. From you as an individual—interest and collateral are usually enough. To a business employing many people, the cartel may require influence a labor union might bring to bear; to a politician, his/her support of particular legislation, or their promise to appoint people selected by them to head various departments. In vetting Barak Obama for the Democratic nomination for President, it is likely he would be required by the Israel lobby, AIPAC<sup>9</sup>, (if elected) to appoint many Zionists to top positions of responsibility; at least, that appears to be the standout result of Obama’s Presidency. top positions in government and banking firmly in Zionist control, and the priorities of the Zionist agenda.

Lending money—getting somebody on the hook for interest payments is the cartel’s key to power. In 1913 a private bank known as “The Fed” was authorized by Congress to control the nation’s currency supply—to *create* all the money the government needs, *lend* that money to government and member banks, and *collect interest* on that loan that *you will pay* through the Fed’s manipulation of interest rates (Inflation) and the Income Tax (IRS)<sup>10</sup> signed into law that same year. These processes have reduced the value of the U.S. paper dollar to about four cents at this writing (2012).

This Federal Reserve Bank *is owned privately* by the Rothschilds, Rookerfellers, Morgans, Warburgs, and a few others. *It is their personal property!* It knows no national or religious allegiance; it favors no political party as those functionaries are too menial for their global interests. It answers to no authority, not even the President or Congress. It is *documented* that cartel money financed both sides in two World Wars and Vietnam.

That sounds incredible! How could we not see forces so powerful and understand what they were about? When you are told the truth, and the evidence of a powerful hidden force is laid before you, denial will be common, even unwillingness to listen. “We have freedom of the press in this country... nobody controls our media!”

You may honestly believe that—most do—so let me ask if you believe the people who own or control our media outlets, television, magazines and newspapers, are different from you? Wealthier perhaps and better positioned in society, but aside from those things do they have extraordinary insights or powers that set them apart within our species? Most will have inherited their position and circumstance and will be normal in the accepted sense. Let me ask: what political party do you favor? Okay, so, do you feel a slight to moderate annoyance when you learn the candidate from the other party has a huge lead in the polls?

Arthur Ochs Sulzberger Jr., a Zionist, is the publisher of the New York Times. His family has been in control of the New York Times Company for more than one hundred years. Arthur Ochs Sulzberger Jr. is an unabashed liberal Democrat. Can you imagine he feels the exact same “annoyance” reading those polls? Can you believe that the five people directly below Arthur, Jr. on his media food chain, as well as every aspiring editorial writer are totally aware of Arthur, Jr.’s political leaning? If you were any one of the above would you think twice before writing a flowery piece extolling the merits and virtues of the Republican poll leader, or would you mention the facts with as few flourishes as possible?

Arthur has told you he wants the unvarnished truth for his paper but he’s human. He gets annoyed and if you become a frequent annoyance you should expect to be near the bottom of the next promotion list. We are human and have certain “leanings.” The New York Times has definite liberal Democrat leanings that spill over on other properties: the Boston Globe and several radio and television stations, all under the Times umbrella. Rarely will this group offer a complimentary, in-depth editorial on a Republican initiative. You may get most of the necessary facts but usually followed by a rebuttal and no flowers.

This happens in most major media outlets in the country and it just happens that they will favor the liberal Democrat, big and expanding government position. Ergo, Zionists and the Democratic Party control the major portion of our media so you can be assured of getting *their* slant on everything presented. In a larger picture that is a minor matter. When it suits the Banking Cartel’s needs, the Republican position will be given the full, flowery treatment. The cartel will order it.

Media heads and bankers share the same social circles and often meet informally. Imagine you are a media mogul and riding a golf cart to

Banks control the media by making their wishes known one way or another, before granting a loan. Hollywood also is under Zionist control<sup>12</sup> and uses its propaganda clout effectively.

Boasting in his memoirs, David Rockefeller extends his gratitude to representatives of major newspapers and magazines for allowing four decades of "discretion" i.e., not informing the public of the destabilizing activity of his father's General Education Board conceived in 1902. Without said discretion, David admits, plans for the New World Order ruled by an elite group of bankers and intellectuals could not have advanced to its present stage.

### **HOW THE BANK CARTEL CONTROLS EVERYTHING ELSE**

Giant corporations are direct tools the bankers use to exercise their control; they experience the same need to borrow pressures. The banks are happy to lend and exact the same tribute they require from the media.

Politicians always need to borrow to campaign effectively. Donations and fund-raising will contribute only a small part of what is needed to run a successful campaign; the Banking Cartel will supply the rest to candidates of its choice. To be supported for a nomination to the national stage a candidate will meet with AIPAC and/or a cartel banker who will question his/her “intentions” regarding certain issues, require some “conditions” for the bank’s support, some “secrets” to be kept whether the candidate wins or not. The candidate needs the money and I leave it to you to estimate the percentage that will readily agree to any terms the bank requires. **All candidates are required to support Israel.** (Wonder why?)

Congressional voting indicates the Banking Cartel controls about sixty-plus-percent of politicians on the national stage; another source places the figure near eighty percent. It may have struck you by this time that banks control everything of importance, and your next logical question might be: “Who controls the banks?”

In his best-selling book, “The Creature from Jekyll Island,” G. Edward Griffin provides the dynamic and startling answer: At the top of the controlling heap is where we find “The Fed,” a Rothschild-Zionist private corporation masquerading as a federal entity holding the exclusive right and license to control all of our nation’s currency. When government and member banks need to borrow, the Fed delivers whatever they need as a *loan* requiring interest payments. In earlier days, the Fed directed the Treasury Department to print whatever amount was needed; today (2013), “...the borrower gets the cash in the form of a digital transfer.”

“Transfer from where?”

“From the Federal Reserve.”

“Does the Federal Reserve have those funds on hand to transfer?”

“No, funds are created digitally from Ben Bernanke’s imagination.”

Now, the borrowing entity owes interest payments to the Fed (Rothschilds, Rockefellers, Morgans, Warburgs, et al.), for money

*created from nothing.* Forget repayment of the principle; it never existed in the first place. Interest payments on imaginary dollars are the new reality.

(These uncomplicated illustrations may cause you to think I write this for fifth-graders, but it really is this simple. The private owners of the Federal Reserve with their Elite contemporaries believe they are the exalted families fit and destined to rule the world. One can hardly blame them when viewing what daytime television offers Americans as entertainment.)

When the value of the money in circulation becomes diluted by the digital increase, the Fed engineers Inflation by manipulating interest rates to return things to a manageable state, and this back-and-forth routine has been filling their pockets and increasing our national debt without letup since 1913. Currently there is much hot air in Washington blowing over our national debt exceeding sixteen trillion dollars. Banks and the Federal Reserve claim more than a trillion of that debt. Haven't we allowed the Zionists to steal enough? Why don't we tell them to whistle for their trillion and reduce our debt accordingly? Congress could do it, except for one small thing. Congress doesn't serve you; Congress serves the Zionists of Israel that they dare not admit.

## CHAPTER TWO – GOVERNMENT and WEALTH

“The world is governed by very different personages from what is imagined by those who are not behind the scenes.” —Disraeli

This chapter combines “Government and Wealth” with a nod to Murphy’s Laws that include a fact about those who have the gold. About the former topic, G. Edward Griffin has written:

Those who drafted the American Constitution believed that a democracy was one of the worst possible forms of government; they created what they called a republic. Unfortunately, that word no longer has the classic meaning it did in 1787. Today it is used indiscriminately for everything from military dictatorships, such as The Republic of Angola, to collectivist dictatorships such as the Republic of China. But, when the American Republic was created, the word had a precise meaning and it was understood by everyone. This is why the word democracy does not appear in the Constitution; and, when Americans pledge allegiance to the flag, it’s to the *republic* for which it stands, not the democracy. ...

The seed of individualism<sup>15</sup> was firmly planted in American soil, but it was poorly cultivated and soon was crowded out by the weeds of collectivism.<sup>16</sup> When the Founding Fathers passed away, so did the Spirit of 76 that was unique to their generation. The new generations, no longer threatened by tyranny from abroad and having no perception of the possibility of tyranny from within, became more interested in material comfort and pleasure than in the ideology of freedom (Griffin/Chasm p. 15-16).

ALERT 2: Following is the second of two realities that in the future will guide you to the answer whenever a national result or issue does not make sense, you will see that only Zionists benefit from it, and—when considering a Socialist form of government now called “collectivism,” or “progressive,” remember this giant distinction: the electorate can “vote” to take your house or business for the good of the state. Under the “individualism” rules of a Republic, the state cannot vote to take your house... at least it could not until a flurry of post 9/11 laws were rushed into place trashing the Constitution. (Sense the vitriol mentioned in the Introduction.)

Writing this book for college-age students I am embarrassed to have lived so long and remained as naïve as I must confess. My only defense is: I wanted to believe; I needed to believe. It’s my government, for God’s sake! If I can’t believe my government what kind of future will I encounter? Where can I place my trust? You may have already asked those questions; you’re a lot smarter than my generation at your age, and with your access to the miracle of the Internet the gap might be in light years.

A veritable library of letters, faxes, telegrams, orders, and other documents dating before World War One requested by the Freedom of Information Act has uncovered disgusting details of our government’s actions in times of stress or when things were not going its way, actions so repugnant as not to be believed. Still, the evidence exists. Much of that evidence is cited and confirmed in the memoirs and autobiographies of participants. Many of those were confessions to be released posthumously.

**There is an account of a plan: In 1915, the cruise ship “Lusitania” with vacationing passengers and tons of military supplies for England was deliberately sent into waters known to be the hunting grounds of German submarines to provoke an attack that would shock the American people and allow President Wilson the public outcry he needed to enter WW I. The plan worked, and 1,195 lives were knowingly sacrificed to that plan, including 123 Americans. Who was behind that plan, and why?**

**There is an account of a similar strategy employed by President Franklin D. Roosevelt in 1941 to lure the Japanese into attacking Pearl Harbor. Many in our government *knew the date* of the attack, and *from which direction* it was coming, but withheld that information from General Short and Admiral Kimmel, the military**

**defenders of the Hawaiian Islands. That plan also worked sacrificing 2,388 people killed, another 1,178 wounded.**

\*\*\*

**There is an admission by former Secretary of Defense, Robert S. McNamara, and supported by several subsequent investigations, declaring that the actions of North Vietnamese torpedo boats attacking the USS Maddox and Turner Joy on August 4, 1964 that created the “Gulf of Tonkin” incident *never happened!* However, confusing reports of actions on that day were purposefully used by President Lyndon Johnson to obtain a “Congressional Resolution”<sup>17</sup> to attack North Vietnam beginning an eleven-year undeclared war that sacrificed 58,148 American lives, more that 60% of whom were under twenty-one years of age. Who wanted this war, and why?**

\*\*\*

I don't want to risk turning you away by going into what some in the government knew on 9/11, *before the World Trade Center attacks!* In due course it will come up. (CLUE: No plane hit the Pentagon, so what made that big hole? No plane hit Building 7, so, what brought it down?)

These incidents alone defy credibility. But when you read of them, examine their provenance from so many valid sources, you cannot help but *know* the truth. I think about all the men and women who gave their precious young lives for this country in its wars believing as I did, that our government was truthful in declaring its needs, that the sacrifice of lives was vital to our very existence, and that there was no other way. Proudly, they went to war and gave all they had, and I mourn for them; I remember them, and I cry for them.

Individualism, so carefully nurtured by the Founding Fathers is in the struggle of its life with the armies of collectivism. The bad news about government will be easier to understand when you realize it really controls very little; it serves the higher master and acts in any way it must to carry out the will of that master: the Banking Cartel. It is this cartel that controls *everything!* the apex of the global pyramid.

**You may already know your government is lying to you about one of the most important matters humanity has ever faced: UFOs and extraterrestrials. **grave are cures for cancer proven effective years ago. A strong case involving the film production facilities of Stanley Kubrick raises serious doubt that Neil Armstrong—or anybody else—ever set foot on the moon, and is, curiously, reinforced by Armstrong’s refusal to swear on the Bible that he did. Rest in peace, Neil... rest in peace.**

\*\*\*

That last one about Neil Armstrong has me scratching my head. The evidence of bold-type matters preceding it is chiseled in stone but I cannot conclude on the moon landing controversy. The claim has many respected scientists in support and for that reason it deserves inclusion here begging your own intense investigation.

Along with revelations of historical errors uploaded by often contentious researchers, “disinformation” like the Warren Report and the 9/11 Commission by government sources and sympathizers designed to preserve the **sacred status quo** requires your equally close examination.

It will not surprise you, this work is biased against government because of its policies of censorship, outright lying, withholding or rewriting evidence, redacting controversial reports, using unwitting citizens and service men and women as guinea pigs in chemical, biological, and radiation experiments, ordering files sealed to far-future dates to protect the guilty, and the “classification” of documents—all policies intended to *keep the truth from the public!* However reluctantly, I suffer a willingness to give the offenders their due when my research indicates.

My use of the word “government” needs explaining: Most of government is made up of modest people earning their daily bread; they are merely “parts” of a whole and few have access to the big picture. They are doing a job, hopefully to the satisfaction of their immediate superiors; few worry beyond that. You can exclude this majority from those few at the top I refer to in derogatory terms—they are non-political except for their membership in a chosen political party. It is the high echelons of government responsible for how “the big picture” plays out—elected officials and those appointed to advise them—Congress, the President and his cabinet and Military overlap that are the focus of my derision.

Look closely at typical politicians. Pay attention to how they answer questions. It seems the words “yes” and “no” are missing from their lexicon while convoluted pronouncements are a specialty. They have massive egos and are always “... guilty of no wrongdoing.” That phrase will be the inevitable response when he/she is caught, regardless of the charge or accusation. More often than not, that response will be a

lie because an estimated nine out of ten of these people have little interest in serving anyone but themselves. They enter politics for either or all of three reasons: they imagine they are suited to rule and relish the power they might achieve when elected; they are “drafted” to run by an entity needing a voice in Congress; they know it’s a great place to get rich! It’s more than their salary they vote to increase at every opportunity—they are suddenly in a position to know things *before they happen*. According to CBS “60 Minutes” on June 17, 2012: Congress has licensed itself to cash in on information not available to the public; a no-risk gateway to riches. You and I (and Martha Stewart) go straight to jail for doing the same.

Many will pad their departure from politics by championing a particular private industry or corporation to whom they will later sell their knowledge and influence for a high-paying position “on the board.”

**“You may already know your government is lying to you about one of the most important matters humanity has ever faced: UFOs and extraterrestrials” and about the government cover-up of its knowledge of extraterrestrial visitations to earth after the Roswell incident on July 4, 1947.**

Alien visits to Earth occurring over thousands of years would be given more attention in history books, news sources, and conversation, but long before alien encounter evidence could be recognized for what it was, the priests and governors had already answered all the questions on just about everything. They couldn’t go back and edit their work or correct themselves without losing considerable “face” and your confidence in their ability to rule.

There are hundreds of web sites describing details of alien encounters, thousands of encounters. Regarding these you can do no better than to look closely at the first UFO crash, July 4, 1947, to make headlines in Roswell, New Mexico. The fiasco of lies initiated by Brigadier General Roger Ramey will live forever in ET annals providing a blueprint of what you can expect from the military and politicians whenever the inconvenient fact of alien visitations rears its head. Expect lies from beginning to end. Worse—people who participated in removing the Roswell wreckage and bodies were *threatened* to keep silent, or else! Threatened! Imagine that! Imagine it was you who helped lift the bodies of aliens to an ambulance and then had government suits show up at your door and threaten you or your family with harm if you reveal what you know. They claim we (the public) cannot handle the truth of aliens, but I already have. What I cannot *handle* is being threatened by my own

government to keep silent to preserve *their* agenda. The truth behind the veil of secrecy is that our arrogant military leaders would be forced to admit they are *not* the “baddest game in town.”

“Roswell” became the buzzword of UFO enthusiasts for decades and started an avalanche of reports of the unexplainable that today number in the thousands. Consider the denial by our government. Then consider *if just one* of those reports actually describes an alien visitation, that’s all you need to be assured of our vulnerability. You won’t want to recall how *we* treat the indigenous peoples (Indians, Vietnamese) when we decide we want their resources or their lands. It should be obvious: if the alien visitors wanted our country they could have had it long ago because our belligerent military with their policy of “shoot them down” has failed miserably. That could be a good thing.

The Roswell event begins on July 4, 1947 in southeastern New Mexico when rancher Matt Brazel discovers a debris field of considerable size in a remote area. Examining the pieces he concludes they are the remains of an aircraft of a type he cannot identify bearing characteristics totally different from anything familiar. He collects some of the wreckage and contacts Chaves County Sheriff, George Wilcox, who advises him to show what he has to the Commander of the nearby U.S. Army Air Base. Major Jesse Marcel, Intelligence officer, and one other are assigned to have a look at the debris field and report back.

After receiving Major Marcel’s report, Colonel William Blanchard orders Lt. Walter Haut<sup>18</sup>, the base public information officer, to inform the local newspaper they had in their possession an unidentified flying disc. The hot topic is quickly picked up by major news services and Marcel is ordered to bring the collected debris to 8<sup>th</sup> Air Force Headquarters in Ft. Worth, Texas, where the actual government cover-up is initiated by Brigadier General Roger Ramey. The General switches the Marcel UFO debris with the hastily procured remains of a weather balloon and photographs that display while issuing a statement there was no UFO crash—it was all a mistake. Everyone witnessing the event and debris is threatened to keep silent; it is declared a non-event.

The wreckage of this non-event is hurriedly surrounded by guards and shipped to Wright-Patterson Airfield near Dayton, Ohio. A few items went directly to Washington and in the days following, the government confirms the weather balloon story and the public, believing their government as they did in those days, soon forgot the matter.

**The second man is Foster Gamble, who, with his wife, Kimberly Carter Gamble, tells what our rulers are doing with their power. The Gamble's "ThriveMovement.com" covers many of the matters I am writing about.**

In the first ten minutes of his video, Foster Gamble introduces himself and his purpose. Morgan, who had a monopoly on the copper used for electrical lines, recognized how Tesla’s invention could transmit electricity without wires. He then shut down Tesla’s funding. Tesla’s lab was burned down and he was ostracized, all for trying to implement his vision of unlimited energy for everyone. A modern-day inventor, Adam Trombly, was inspired by Tesla’s work and by the possibilities of the torus. Trombly built a dynamo, a direct-current generator that accessed electrical power right out of the air (Gamble/Thrive 0:34:00).

Adam Trombly explains:

“We were trying to demonstrate that by mimicking the magnetic field of the planet and rotating this device, we could actually create a dynamo that would work, and in fact, it did work, and it does work” (Gamble/Thrive 0:35:00).

The video continues describing how the dynamo is behaving exactly as the torus universal forces surrounding our planet, equating it with the activity of a magnet rotating in space. Trombly continues:

Expanding and contracting, it's breathing, it's taking in the energy in space literally, and transforming it right there in this torus, we have enough energy to transform the entire earth... and that's not just a theoretical statement, it's literally true. To contemplate the implications of this it means that every single place on earth suddenly has power. Every single person on earth suddenly has power. We have universal abundance (Gamble/Thrive 0:35:50).

Foster Gamble describes the fate of Adam Trombly's discovery:

"Trombly had been invited to demonstrate one of his generators at the U.N. and the U.S. Senate, but these events were undermined by the first Bush administration, then the device itself was taken in a government raid" (Gamble/Thrive 0:36:00).

The treatment of Adam Trombly was not unique. Everyone Gamble interviewed who had an energy saving device, had a similar tale to tell. Foster Gamble continues:

Inventor John Bedini began working with Tesla's theory of radiant energy decades ago and has produced an assortment of battery charging devices that generate more energy than it takes to run them. He announced that he was going to start offering them at low cost. Soon after that he was attacked in his lab and warned not to produce the devices. For his own safety, he had to let go of marketing free energy. ... Canadian, John Hutchison, not only created free energy batteries, but also used Tesla's theory to counter gravity to make objects float. This could revolutionize the field of propulsion. His lab was raided and equipment was taken by police and government officials in 1978, 1989, and again in 2000. One of the scientists we were going to interview for this film was Dr. Eugene Mallove [Scientist, Publisher], an engineer from MIT and Harvard, editor of Infinite Energy Magazine, which covers both theoretical and technological developments in the New Energy field. Dr. Mallove was mysteriously beaten to death in 2004 (Gamble/Thrive 0:36:35).



Dr. David Greer relates:

The energy is extracted from the fabric of the space around us, which means it cannot be metered. That is a direct threat to the single largest industry in the world, energy. It's good-bye Exxon/Mobil, good-bye oil, good-bye coal, good-bye linear transmission of electricity, power lines, all of that gone. Unfortunately, it's someone's two-hundred trillion dollar piggy bank. The proven oil and coal and gas reserves are worth north of two-hundred trillion dollars (Gamble/Thrive 0:39:00).

So, given the stakes, I [Gamble] decided to ask, who's benefiting from suppressing scientific research? Whose wealth and power are threatened by access to clean, free energy? Who has a motive to set up a world where so few have so much and so many have so little? As an independent researcher, I followed one of the cardinal rules of investigative journalism; if a story doesn't make sense, follow the money.

The Rockefeller oil empire got started in 1870 when John D. Rockefeller founded Standard Oil and became America's first billionaire. Standard Oil has since morphed into Exxon/Mobil and others. And the Rockefellers control our food as well. They were primarily responsible for the global shift to large-scale petroleum based agriculture (Gamble/Thrive 0:43:50 – 0:44:15).

In 1973, Henry Kissinger, a member of the CFR, BIL, TC,<sup>19</sup> and one of the most insidious and traitorous conspirators of our time, stated: "Who controls the food supply controls the people; who controls energy can control whole continents; who controls the money can control the world" (qtd in Gamble/Thrive 0:46:40).

**“It [our government] buries the technology of free, non-polluting electric power to preserve our dependency on oil...” and sharing that grave are cures for cancer proven effective years ago.”**

Foster Gamble explains how suppression of cures works:

The American Medical Association is largely funded by the Rockefeller Foundation who use their funding to influence AMA research and decision making. How far would these forces go to make a profit? Would they actually suppress cures for diseases the way they suppress free energy technology? Sadly, my research has shown me, the answer is yes. One well-documented example is the case of Doctor Royal Rife. In the 1920s, Dr. Rife invented the most advanced microscopes of his time. He also developed a technique he called, “coordinated resonance,” which was apparently able to destroy cancerous tumors as well as viruses. In 1934, in clinical trials affiliated with the University of Southern California, Rife’s treatment was tested on sixteen terminally ill cancer patients. Within three months, they were all successfully cured. Soon after, a lab testing Rife’s technology was burned down, and a frivolous lawsuit was filed. Through the efforts of Morris Fishbein, head of the Journal of the American Medical Association, Rife was essentially shut down and ruined; his brilliant and promising work all but forgotten (Gamble/Thrive 0:48:20).

Foster Gamble’s wife, Kimberly, responds to this news:

It was really hard for me to imagine that someone might actually be suppressing cures, and cancer has run through my family like a raging river. I found out that it’s all about patents. If a pharmaceutical company can patent and make money from treatments, especially if it’s one that we have to keep on using, then that’s what we get, otherwise, we don’t even hear about it. It’s not just Rife that got shut down. Rene Casse had an old Indian formula that was effective. Harry Hoxey and Max Gerson had natural remedies that worked, but if you go and look them up, the AMA makes them sound like complete quacks. And that’s where following the money has been so helpful because the same powers that control the AMA and their

research and funding, control the pharmaceuticals. So there's a multi-trillion dollar financial incentive to suppress cures that can't be patented. Knowing that cures exist has not taken away the anguish I feel from losing so many people I love to cancer. It's given me something really satisfying to do with the pain. And I believe that when we take the love and devotion that we have for everyone that's died, and who will die unnecessarily, and direct it to developing and getting these cures out to people who need them, we can break this cancer legacy and heal (Gamble/Thrive 0:50:45).

Foster Gamble continues:

If oil and food are controlled by the big banking families, where else does their influence show up? As I followed the money I began to see the same pattern of control in just about every area of our lives, and I always found the same families in charge, either directly through their banks and corporations, or indirectly through their major foundations.

Again, it was the Rockefellers who created the National Education Association with help from the Carnegie Foundation, and later from the Ford Foundation. What the captains of industry wanted from our schools was an obedient and docile work force who would be manageable employees and eager consumers.

Continuing, the Thrive website steps through the Rockefeller education controls, the medical and pharmaceutical monopolies, and the suppression of cancer cures. John Gatto, a New York State Teacher of the Year tells:

Schools are to establish fixed habits of response to authority. That's why it takes twelve years. You are to respond reflexively when anyone in a position of authority tells you what to do (Gamble/Thrive 0:48:00).

## **THE ROCKEFELLER PLAN FOR EDUCATION**

I grew up hearing about the Rockefeller Foundation, the Rockefeller money donated to one charity after another, and formed a favorable impression of those good people that lasted late in my life. I

was not of their world so, over time, my scrutiny was less than penetrating. It was only recently while researching this work that I dug down to the roots of their Foundation and contributions. When I compared my findings with those of others who had done the same years before, I suffered a blow to my perceptions as sudden as a train wreck. The Rockefellers were not charitable people concerned with the uplifting of mankind; they were world-class schemers using charities to mask their primary purpose for living: to join with the bankers and enslave everyone they could touch that was not near to, or above, their social level.

The turn of the twentieth century offered fertile ground to facilitate those ambitions as the death of Cecil Rhodes in 1902, one of the richest men in the world, provided an enormous fortune to the society sworn to advance his belief that the people of the British Empire were the finest in the world and the more countries that could be brought under their control, the better for mankind. Ninety percent of Americans who have heard of “Rhodes Scholars” believe them to be extraordinarily gifted people while having no idea of the nature of those gifts that in fact, have the Founding Fathers turning in their graves. Cecil Rhoades had been an admirer of the then-dormant Illuminati and considered it his mission to bring their ideals of “collectivism” under British rule to fruition. Rhodes Scholars are educated in long-term strategies on how to erode a nation’s sovereignty and prepare it to accept the New World Order that they would control. The United States is their prime target.

Early in the last century, Catherine Casey was an attorney on the staff of Norman Dodd, chief investigator for the House of Representatives “Reece Committee”, charged with determining whether tax-exempt foundations were involved in un-American activities. So, then they raised question number two, and the question was, “How do we involve the United States in a war?” (Dodd/Author/92).

To be effective, they concluded they must control the State Department; the diplomatic machinery of the United States. Altering the

life of Americans became the objective of the Carnegie Endowment and their thoughts shifted to determining the means.

Soon after, World War One broke out offering one solution. A telegram was sent to President Wilson advising him of the benefits of a prolonged war. It would seem the existence of such a telegram would totally unnerve a President or CEO today; obviously, this was a different time.

When the war ended, concern was that the people would return to their old ways and negate the perceived recent benefits. A new determination was reached: the foundation must control the teaching of education to reflect the collectivist programs and for that they enlisted the help of the Rockefeller Foundation. Between them, the foundation's members decided their success lay in the teaching of American history.

We must give them five-stars for their thinking—decidedly, long-range.

Convincing history teachers of the time to switch horses in mid-stream was unsuccessful, so they requested the Guggenheim Foundation to offer fellowships to a number of doctoral candidates of their choosing.
